Marcum-Illinois ES provides each pupil (including English Learners) with their own copy of the Standards-aligned textbooks (approved by State Board of Education) and instructional materials in the core curriculum areas of reading/language arts, math, science, history/social science, foreign language, and health.

All students in visual and performing arts classes have access to the appropriate textbooks and instructional materials. Marcum-Illinois Elementary School offers the following visual and performing arts classes to all grade levels. Marcum-Illinois also provides art and drama that is embedded in the Standards-based, self-contained classrooms.

# **School Facility Conditions and Planned Improvements**

Marcum-Illinois School was established 90 years ago, the current school site was built in 1960. The 2006 modernization included all ten classrooms, kitchen, bathrooms, administration offices, media center classroom, sewer and parking lot. Marcum-Illinois School has a reputation as a safe, clean, well cared for campus. The grounds/custodial staff keeps the restrooms, buildings, and grounds clean and neat.

This past year, we have added chromebooks or ipads for every student. We have completed facility upgrades to the blacktop area and the preschool.

We purchased new appliances for the kitchen and modernized the electrical and plumbing for the kitchen. We also upgraded the playgrounds for the preschool and elementary school.

We provide a safe, clean learning environment in three permanent structures, housing ten classrooms, the main office, multipurpose room, computer lab, library, and kitchen. Portables provide three additional classrooms. Together the buildings accommodate 300 students and 24 preschoolers.
